**BUSINESS OR INFORMATIONAL ITEMS:**

**1. Approve the Customer Addendum between Levy County and Howmedica Osteonics Corp. DBA Stryker Sales, LLC and approve the purchase of eight (8) LifePack 35 Heart Monitors in the amount of \$450,761.16 from Stryker quoted under the Sourcewell Contract Solicitation #041823 in accordance with Sec. 2-200(c) of County Code. (Audio 5:15)**

- **Presenter:** Mitch Harrell, Director Public Safety
- **Discussion:** This purchase is a budgeted capital purchase to replace (8) heart monitors that have met their life expectancy and are no longer serviceable. Manufacturer states 7-8 years life expectancy. The county is getting 10-12 years currently out of these devices.

**2. Approve the letter terminating the Agreement for Request for Proposals No. 2025\_003 – EMS Billing and Initial Collection Services and the Business Associate Agreement with EMS Management and Consultants, Inc. (Audio 7:25 )**

- **Presenter:** Mitch Harrell, Director Public Safety
  - **Discussion:** EMS|MC has not met the expectations of staff and a new vendor is recommended. Issues have come up that vendor has not addressed satisfactorily leading to this action request.
  - **Action:**

**3. Approve the Agreement for Request for Proposals No. 2025\_003 – EMS Billing and Initial Collection Services and the Business Associate Agreement with Digitech Computer LLC.**

*(Audio 10:53)*

- **Presenter:** Mitch Harrell, Director Public Safety
  - **Discussion:** This will enter us into agreement for EMS Billing Services with Digitech as the new selected vendor following the guidelines of RFP 2025-003 completed earlier this year. This vendor came in second in an earlier RFP and has agreed to work with us.
  - **Action:**

**4. Approve Amendment #3 to Agreement between Levy County and Federal Engineering, Inc. *(Audio 12:32)***

- **Presenter:** Clayton Drew, Communication System Manager
  - **Discussion:** This is a time extension for the current agreement to continue the communications project. This extension has no effect on previously approved funding for the project. Federal Engineering, Inc. are the subject matter experts on execution of the P25 radio communications project. This project is scheduled to be completed this fiscal year.
  - **Action:**

**5. Approve the transfer of \$61,540 from reserves from contingencies for E911 Indigital services for fiscal 2026. *(Audio 15:07)***

- **Presenter:** Jason Rivera, Finance and Administration Director
  - **Discussion:** The amendment shall amend the FY25-26 Budget to appropriate funds from reserves for contingencies to provide the necessary funding for E911 services. This grant was received in the prior fiscal year and was not fully expensed. The remaining funds were not included in the budget for this year and the funds were swept into reserves. This request will reestablish this item in the proper budget line and allow it to be fully completed and expensed.
  - **Action:**

**6. Approve the priority ranking of roadway project in the 5 year Capital Improvement Plan and direct staff to apply for FDOT funding. *(Audio 15:50)***

- **Presenter:** Donald Clifton, Road Department Director
- **Discussion:** With approval of this capital improvement plan, the BoCC directs staff to make these roads a priority and to apply for FDOT funding. FDOT has now opened the application period for roadway project funding with a deadline of January 23, 2026. The roads approved are as follows:
  - C347 Part 1 (C347 Begin at SR 24N 6.034 miles to Satellite Station) (programmed 2029)
  - 1. C347 Part 2 (C347 Begin at Satellite Station to MP 12.5 for a total of 6.46 miles)



- 2. C347 Part 3 (C347 Begin at MP 12.5 to C330 for a total of 7.69 miles)
- 3. C326 Part 1 (C326 Begin at US 19 to Powerline at Crystal Water for total of 5.11 miles)
- 4. C326 Part 2 (C326 Begin at Powerline at Crystal Water to C337 for a total of 4.3 miles)
- **Public comment:**
  - Emily Casey (Gulf Hammock) mentioned CR 326 from Hwy 19 to the Waccassassa Boat ramp as a roadway that needs widening and has a speed limit that is too high for the width of the roadway.
  - Terry Witherell (Gulf Hammock) CR 326 is a busy road with boat trailers and vehicles.

**7. QUASI-JUDICIAL PETITION NO. SE22-02A: requesting a Minor Amendment to a Special Exception pursuant to Sec. 50-676, Sec. 50-746 and Secs. 50-796 through 823 to allow a Travel Trailer (also referred to as a Recreational Vehicle) Park on approximately 11.94 acres of land located in Section 30, Township 14 S, Range 14 E, Levy County Florida. (Audio )**

- **Presenter:** Bo Cox, Development Service Director
- **Discussion:** Owner and Developer requests the approval of the BOCC to Amend Petition No. SE 22-02. Taking into consideration County Code SEC. 50-755 (e) "Amendment. (1) Minor amendments. An amendment to an existing special exception shall be considered minor where it will not cause an expansion to the existing use, or additional impacts to surrounding properties, natural resources or public infrastructure. A minor amendment does not require a planning commission public hearing and instead may proceed to the board for one hearing with a written order. (2) Major amendments. A major amendment to an existing special exception is any change that is not deemed to be a minor amendment. A major amendment to an existing special exception shall be reviewed during the same process as an initial application.
- BoCC heard from applicant. Applicant states project has been delayed due to agencies taking longer to respond to permitting and is asking for more time to the end of 2027 for completion.
- **Action:**

  - Vote Outcome: 5-0

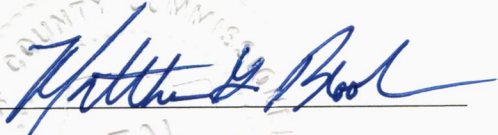

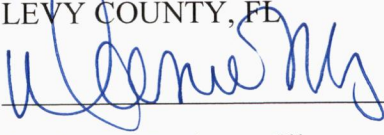
